

ORDINANCE NO. 2016- 5

AN ORDINANCE OF THE BOROUGH OF STEELTON,  
COUNTY OF DAUPHIN AND COMMONWEALTH OF  
PENNSYLVANIA, FIXING TAX RATES FOR THE FISCAL  
YEAR 2017.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Borough Council of the Borough of Steelton, County of Dauphin and Commonwealth of Pennsylvania:

SECTION 1. That a tax be and the same is hereby levied on all persons owning property within the Borough of Steelton, Dauphin County, Pennsylvania and subject to taxation for Borough purposes for the fiscal year 2017 beginning the first day of January, A.D. 2017 and ending the 31<sup>st</sup> day of December A.D. 2017, as follows to wit:

(1) (a) Tax at a tax rate for general purposes, 15.0 mills on each dollar of assessed valuation on real estate classified as non- farm land and 15.0 mills on each dollar of assessed valuation on real estate classified as buildings on land pursuant to 8 Pa. C.S.A. § 1302.1.

(b) For purposes of this section:

(1) "Farm Land" shall include any tract of land that is actively devoted to Agricultural use, including, but not limited to, the commercial production of "crops, livestock and livestock products" as defined in Section 3 of the Act of June 30, 1981 (P.L. 128, No. 43) (3 P.S. § 903) known as the "Agricultural Area Security Law".

(2) "Non-Farm Land" shall include any tract of land that is not farm land.

SECTION 2. That a tax be, and the same is, hereby levied on all occupations within the Borough of Steelton subject to taxation for the fiscal year 2017 as follows:


(A) Tax Rate for general purposes 20 mills on each dollar of assessed valuation pursuant to 8 Pa. C.S.A. § 1302(b).


SECTION 3. That a tax be, and the same is, hereby levied for the purpose of payment of interest and principal on indebtedness pursuant to 52 Pa. C.S. Pt. VII Subpt. B (relating to indebtedness and borrowing), 2 mills on each dollar of assessed valuation.

SECTION 4. That any ordinance, or part of ordinance, conflicting with this Ordinance, be, and the same is, hereby repealed insofar as the same affects this Ordinance.


