Major Tax Incentive Enacted for Home and Business Improvements

Holding off on renovating your business or home because of the potential property tax increase?

Wait no longer! Steelton Borough's new Local Economic Revitalization Tax Assistance (LERTA) and Improvement to Deteriorating Real Property (IDRP) program gives homeowners and businesses a break of up to ten years on any additional county, borough, and school district taxes that result from property im-

provements.

What is the LERTA/IDRP Program:

Participants receive relief on any new taxes that result from improvements to their property. As a result, residents and businesses can renovate their property and raise its value without paying additional *borough*, *school*, *and county real estate taxes*. The program also applies to new commercial and residential construction!

How to Get the Tax Break:

Step 1: Commit to improving your property.

Step 2: Fill out a LERTA/IDRP Application as part of your building permit at the Steelton Codes Office.

Step 3: Renovate your property.

Step 4: Receive a break on new real estate taxes for up to ten years.

Determining the Amount of Tax Relief You'll Receive:

The amount of tax relief received depends on which district your property is located in:

- 1. C-1 Town Center District: 100% break for ten years
- 2. Rest of the Borough: 100% break for five years. Break reduces by 20% years six through ten.



Rest of Borough: All areas outside of the C-1 District including the entire East End.



Codes Officer Singh Awarded Master Codes Enforcement Professional Certification

Amrinder Singh, Director of Code Enforcement & Building Code Official for the Borough of Steelton, Pennsylvania has been awarded the Master Code Enforcement Professional Certification by the American Association of Code Enforcement. The Master Code Enforcement Professional (MCEP) is the highest level of certification the organization offers. While thousands of code enforcement officials are certified, only a small number have received this distinction.

Singh is the first Code Official in Pennsylvania and one of ten in the country to earn the certification, which requires and demonstrates commitment to the profession, diverse knowledge of codes, and a high level of self-initiative.



"It is with great pride and honor that the American Association of Code Enforcement grants the Certification of Master Code Professional to you. This is a very prestigious certification and shows that you are highly competent in all areas of Code Enforcement" stated Tana Bryant, 2nd Vice-President and Certification Committee Chairperson for the American Association of Code Enforcement.

To obtain this designation, Code Officials must successfully complete and pass the five exams required by the American Association of Code Enforcement. These exams are administered by the International Code Council. Code Officials must also complete training from the Federal Emergency Management Agency, passing six National Incident Management System courses and exams. Lastly, must be currently employed in the field of code enforcement and have a minimum of seven years of active employment in the field of code enforcement and/or regulation of health or safety.

"I look forward to continuing to learn and grow as a code official by continuing to acquire more knowledge of codes, the latest best practices and techniques for enforcement, and learning what ordinances and methods have or have not worked in other municipalities to help eliminate blight, increasing the quality of life, and property values." said Singh.

SCAM ALERT!

PPL: Don't fall for scammers

Phone scammers who impersonate PPL Electric Utilities give themselves away by doing two things the utility doesn't.

The scammers claim they'll cut off power in an hour or two if they don't get paid, and they often pressure you to pay them with prepaid cards. (In reality, PPL gives plenty of notice when there's a possible risk of shutoff, and the

company doesn't pressure anyone to use specific payment methods.)

If you get one of these calls, you can always check your account status by logging on at www.pplelectric.com or hang up and call 1-800-DIAL-PPL to verify the call.

If you receive a suspicious or threatening call that claims to come from another company – like a gas utility or a bank – do the same thing: Hang up and contact the company directly using a trusted method, like the phone number on your monthly statement or from the company's website.

At PPL, service termination always is a last resort. The utility works with customers to set up payment plans or to enroll customers in income-eligible programs whenever possible. When termination does occur, it's preceded by a formal notification process that involves a letter and phone call, as well as a door posting at the address in question.

Please share this news with your family members and friends, so that they can also watch out for phone scams.



Be Alerted During Emergencies: Sign Up for Code Red

Borough residents can receive phone call notifications during emergency events like the recent propane leak. All residents are encouraged to register their phone number with Code Red. During emergency events, including evacuations, the Borough will call residents in the Code Red System to keep them updated.
