RESOLUTION AMENDING RESOLUTION 2011-R-11, "ADOPTING A RATE SCHEDULE PURSUANT TO ARTICLE XI (SIC) OF CHAPTER 90, "SEWERS" OF THE CODE OF THE BOROUGH OF STEELTON, PENNSYLVANIA", BY ESTABLISHING NEW SEWER USAGE RATE CHARGES.

WHEREAS, pursuant to the provisions of the Code of the Borough of Steelton,
Pennsylvania, Chapter 90, "Sewers", Article X, "Rate Schedule", Section 90-109 "Adoption of
Rentals, Charges, Fees and Rates by Resolution", the Borough did adopt Resolution 2011-R-11,
adopting a rate schedule fixing the consumption charges and minimum charges for sewerage;
and

WHEREAS, the Borough Council has determined that it is necessary to reestablish sewer rate charges.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY RESOLVED by the Borough Council of the Borough of Steelton as follows:

- 1. The quarterly charge for sewer rental is hereby established as follows:
  - A. USAGE RATE PER 1000 GALLONS OF WATER USAGE:

B. HOME OCCUPATION – Whenever a business enterprise is conducted within a dwelling unit, the quarterly sewer rental shall be per user, per quarter.

- 2. The increase set forth in No. 1 above for 1/1/2021 shall be effective as of January 1, 2021, and be reflected in the May 2021 Sewer Bill, and the increase for 7/1/2021 shall be effective as of July 1, 2021, and be reflected in the November 2021 Sewer Bill.
- 3. Except as otherwise amended (see 2010-R-35 regarding tapping fees), Resolution 2004-R-31 shall remain in full force and effect and Resolution 2011-R-11 is repealed.
- 4. The officials, employees and agents of the Borough shall take all actions necessary to implement the provisions of this Resolution.
